Faculty of Hospitality and Tourism (FHT), Prince of Songkla University, Thailand, and Tourism Faculty, Isparta University of Applied Sciences, Turkey believe that mutual benefits can be derived by bridging their two faculties, achieving a closer relationship by linking their scholars, students, and personnel. Both faculties share the strong conviction that mutual understanding among people can be promoted through the establishment of academic links. Therefore, both faculties agree to enter into this Memorandum of Understanding (MOU).

***Article I: Principle of Cooperation***

FHT and Tourism Faculty of the Isparta University of Applied Sciences, agree to develop their academic links under the principle of mutual understanding, mutual benefits, common interests, and mutually complementary activities.

***Article II: Objectives of Cooperation***

- (1) to promote individual contacts among scholars, students, and personnel of both faculties,
- (2) to promote links in teaching, research, and cultural activities,
- (3) to provide opportunities for both staff and students exchanges, however, such exchange need not be equally reciprocated,
- (4) to develop and to encourage joint research, seminars, conferences, workshops, and to also assist each other in obtaining external funding from outside sources,
- (5) to develop, when opportunities avails, joint study programs,
- (6) to support the exchange of academic materials,
- (7) to share experiences and expertise concerning faculty administration and management,
- (8) to encourage any other activities that both faculties agree to be of mutual benefit.

***Article III: Areas of Cooperation***

Areas of cooperation can include any academic or other programs offered by FHT and Tourism Faculty of the Isparta University of Applied Sciences.

#### **Article IV: Implementation**

It is understood and agreed that:

- (1) Proposals for collaborative projects under this MOU will be submitted through the Dean of each faculty, and it is recommended that reports should be submitted to each Dean at the completion of each project.
- (2) Each faculty will continue to pay the regular in-country salary of its staff members on exchange or visiting programs. However, under specific contracts or secondments, the host faculty may consider paying a supplemental salary to visiting scholars during the period of their assignment.
- (3) To encourage student mobilization, the host faculty will assist in every way it could in finding reasonable accommodation for participating students.
- (4) Student mobilization will apply to undergraduate and graduate/post graduate students at both faculties, and may include practical or industrial attachments.
- (5) Financial arrangements for collaborative research, seminars, workshops, conferences, and other such activities will be negotiated separately and will be subject to the availability of funds.
- (6) The host faculty is not responsible to cover the costs of medical treatment or hospitalization for visiting scholars or students, and it is recommended that visitors obtain overseas health insurance coverage from their home country.

Therefore, both universities agree to enter into this Memorandum of Understanding (MOU).

***Article I: Principle of Cooperation***

## MEMORANDUM OF AGREEMENT BETWEEN

The Parties below



<b>Faculty of Hospitality and Tourism Prince of Songkla University, Phuket Campus Thailand</b>	<b>Global Engagement Center, Gingko College of Hospitality Management, P.R. China</b>
<b>Represented by its Dean:</b>  Assistant Professor Dr. Pornpisanu	<b>Represented by its Vice President for Research &amp; Global Engagement:</b>  Associate Professor Dr. Fu Jing

This Memorandum of Agreement (MOA) is made on 17<sup>th</sup> May 2021 between **Faculty of Hospitality and Tourism (FHT), Prince of Songkla University (PSU), Thailand** (hereinafter referred as **Party A**) and **Global Engagement Center, Gingko College of Hospitality Management (Gingko College), China** (hereinafter referred as **Party B**).

Both parties express satisfaction that represents the mutual knowledge, emphasize the importance of co-developing academic, scientific and technological activities, and pursue the broadening of their relations for mutual enrichment. Therefore, both institutions decide to establish a Memorandum of Agreement according to the following terms:

### SECTION I - 1. ASSIGNMENT OF DUTY

#### A: Duty of Party A

- a) Nature of Party A: to conduct 3+2 programs by providing lectures, supervisions, management and granting Bachelor of Business Administration (BBA) in Hospitality Management (International Program) and Bachelor of Business Administration (BBA) in Tourism Management (International Program) of FHT PSU to Gingko College's associate degree graduates, who are required to complete, under normal circumstances, two additional years of study at FHT.
- b) Students' management: be responsible for all academic activities organized in FHT PSU.
- c) Entrance interview: to conduct program entrance interview candidates before the start of the program.
- d) Course implementation: for the pre-BBA preparation courses in Gingko College, FHT should work with lecturers of Party B to conduct the English preparation program (100 hours) at Gingko College.

**B: Duty of Party B**

- a) Nature of Party B: to prepare pre-BBA students by providing lectures, supervision and management in Gingko College.
- b) Students' management: to be responsible for all the academic activities organized in Gingko College.
- c) Recruitment: to co-ordinate the recruitment of students in Party B to study the BBA programs in Party A.
- d) Course implementation: the pre-BBA English preparation courses (100 hours) which should be taught by qualified lecturers agreed by Party A.
- e) Lecturers' responsibilities: to conduct lectures for each pre-BBA preparation course and relevant academic activities according to the requirements provided by Party A.

**SECTION II- ADMISSION REQUIREMENTS**

FHT PSU will accept candidates who meet the following criteria:

- a) Associate Bachelor's degree holders recommended by Gingko College
- b) TOEIC score of 500 or equivalent or successfully complete the pre-BBA English preparation course
- c) Pass the entrance interview

**SECTION III: GRADUATION REQUIREMENTS**

Students from Gingko College are eligible to be awarded FHT PSU's a relevant bachelor's degree provided that they:

- a) complete all required subjects required by FHT PSU with minimum GPA of 2.00 out of 4.00.
- b) obtain minimum TOEIC score of 630 or equivalent
- c) complete all other graduation requirements of FHT PSU

**SECTION IV: FEES AND EXPENSES**

Standard fees and expenses charged must comply with Financial System of FHT PSU and Gingko College.

- a) The tuition fees in FHT PSU for the 2-year BBA program is 236,000 THB (48,000 THB/ regular semester for four semesters, one summer internship of 24,000 Baht and one-time registration fee of 20,000 THB). In case that the student needs to undertake more than the regular program period to complete the program, an additional tuition

fee of 24,000 THB per semester is to be paid. Party A should charge all the registration fees, tuition fees and expenses happened in PSU.

- b) No additional tuition fees are charged from the students for the pre-BBA preparation courses in Gingko College.
- c) The costs for the pre-BBA preparation, courses including program teaching (one course/class), marketing and promotion are paid by Party A at a total amount of 100,000 Baht. In this case, Party B has to have at least five students per course. The payment is transferred to Gingko College when a minimum of five students have paid full tuition fees of the first semester of the BBA program to FHT PSU.
- d) Party A will grant one semester scholarship (tuition fee waived) to a qualified student of Party B if the number of students reaches 11 of each batch of application.
- e) For other mutual visits, receptions should be treated equally by each party.

## **SECTION V: DEFAULT**

- a) It shall be regarded as breach if any side cannot implement the agreement and perform its own duties or responsibilities in accordance with the time, manner and requirements stipulated
- b) If behaviors of the breach side cause the objective of the agreement not being realized or cause economic loss for the counterpart, the breach side shall bear the relevant compensation duties.
- c) If the breach behavior or improper behavior of the breach side violates the legal rights or interest of the students in this education program, or the relevant legal rights or interests of related organizations in the society, or the laws or government decrees of PRC or Thailand, the breach side shall undertake the related legal duties independently.
- d) If the breach behavior or improper behavior of the breach side causes dispute with a third party and involves the counterpart into the compensation affairs, the party who has no fault shall have the right to request the breach side (or the side which has improper behaviors) to indemnify the relevant loss.

The parties hereto shall settle any dispute arising from or in connection with the agreement by friendly negotiation.



## SECTION XI: DURATION AND TERMINATION OF MOA

- a) this MOA is effective as of the date of signature for three years.
- b) this MOA may be amended at any time by written mutual consent of both parties.
- c) this MOA may be terminated by either party by the provision of written notice of termination of no less than six months prior to the desired termination date.

The agreement is duplicated and shall have the same force as the text of the agreement itself.
